A PROCLAMATION

WHEREAS, the people of the State of Wisconsin recognize the critical and indispensable role long-term care workers serve in maintaining the health, safety, and well-being of persons with disabilities and the elderly residents of this state; and

WHEREAS, long-term care workers provide life enhancing care, programs, education, medicines, and emotional support to the elderly and persons with disabilities, and to their families; and

WHEREAS, the recognition and compensation of long-term care workers should reflect their contributions to our society; and

WHEREAS, the long-term care workers of this state deserve acknowledgement of their dedicated efforts in both tangible and intangible ways; and

WHEREAS, the State of Wisconsin's current commitment to restructuring of its long-term care delivery system to maximize an individual's choice of services, providers, and care-settings cannot be realized without dramatic expansion in the availability and skills of its dedicated caregiver workforce; and

WHEREAS, all Wisconsin residents share a common responsibility to assure that the current and future caregivers for its most vulnerable citizens are not deprived of the recognition, support and respect they so richly deserve; and

WHEREAS, I call upon representatives of the private sector long-term care provider community to take steps to continue to improve the status and career opportunities available to long-term care workers in all areas of long-term care delivery; and

WHEREAS, I call upon all related agencies of state government to continue to take steps to identify and implement practices and procedures which will positively affect long-term care workers and the services they provide;

NOW THEREFORE I, Jim Doyle, Governor of the State of Wisconsin, do herby proclaim the month of June 2008 as

LONG-TERM CAREGIVER MONTH

and, I commend the observance of this month to all citizens of Wisconsin that they might properly honor the work performed by long-term care workers.
