

# Wisconsin Top Immediate Jeopardy Citations 2014

### Issues cited at F309

- 4 Failure to provide cardiopulmonary resuscitation to a full-code resident who became pulseless and non-breathing
- 4 Failure to provide appropriate dementia care (e.g., no individualized care plans, no directions to direct care staff, failure to incorporate life interests and skills into daily activities, failure to provide ongoing activities, failure to analyze episodes of extreme distress and agitation to determine possible trigger(s), increased use of psychoactive meds)
- 2 Failure to provide appropriate wound care (e.g., deterioration of ulcers related to peripheral artery disease; did not culture wound as ordered of resident at risk for sepsis)
- 1 Gave oral glucagon to unresponsive diabetic and failed to refill contingency kit
- 1 Did not ensure RN assessment of resident with a significant condition change
- 1 Served food not compatible with mechanical soft diet; person who plated food did not know what foods constituted mechanical soft diet

### Issues cited at F323

- 4 Resident elopement (did not respond to door alarms, did not revise care plan when resident known to remove wanderguard bracelet, did not provide 1:1 supervision as directed by nurse)
- 1 Transported residents in facility van knowing seat belt was broken and could not be used
- 1 Staff did not know how to intervene in resident-to-resident altercation, panicked and left residents alone when altercation broke out
- 1 Allowed resident to smoke outside with oxygen running
- 1 Did not have a key readily available to enter room of resident who had been given permission to lock room door
- 1 Did not have means to protect residents from touching areas around a gas fireplace that were extremely hot to touch

### Issues cited at F314

- 4 Failure to closely monitor newly developed or worsening pressure ulcers and failure to revise care plan with interventions to prevent further deterioration
- 1 Failure to monitor a "skin tear" under an immobilizer, which subsequently developed into a stage 4 pressure ulcer
- 1 Failure to clarify orders from wound clinic for continued care and failure to properly use a wound vac
- 1 Failure to put plans in place to prevent pressure ulcer development on heels of a diabetic resident identified as being at risk for pressure ulcer development, leading to stage 4 pressure ulcer and amputation of foot
- 1 Failure to keep a resident who was at extreme risk for pressure ulcer development from lying on catheter tubing, leading to development of a stage 4 pressure ulcer.

### Issues cited at F281

3 – Allowing an LPN to practice outside the scope of his/her license (e.g., allowing an LPN to be the person who "assesses" wounds; allowing an LPN to give IV therapy infusion that was not pump-controlled without RN onsite; allowing LPN to "assess" significant change in condition without RN consultation)

### Issues cited at F157

- 1 Failure to inform nurse practitioner that a resident who was on Coumadin and who had fallen had hit his head
- 1 Failure to immediately notify physician when a resident was having extreme abdominal pain throughout night and had passed blood the 16-18 times the resident was taken to the bathroom

### Issues cited at F155

2 - Failure to have a system that ensured residents' advance directives were identified and properly and consistently noted in the record.
