



The Underfunding of Nursing Facility Resident Care



Based on two studies, Medicaid was underfunded by between \$307 million and \$325 million in 2017-18. 100%

Private pay residents have to pay \$41,000/year more than Medicaid residents due to the underfunding, resulting in asset depletion and lost homes.

Unfunded direct care was nearly \$100 million in 2017-18. This funding goes toward front-line caregiver wages. Underfunding contributes to lower wage rates, workforce shortages, and increases the potential for substandard care.

- In the 2017-2018 payment year, the difference between the total cost of the care facilities provided their Medicaid residents and the Medicaid reimbursement they received for providing that care, referred to as their Medicaid deficit, was estimated to be between \$307,000,000 and \$324,800,000, according to two association studies.
- 100% of nursing facilities in Wisconsin experienced a Medicaid loss; proving this is a systemic underfunding and not a facility-specific operational issue.
- To help combat the Medicaid underfunding, private pay residents are forced to pay more for the same care. On an annual basis, private pay residents pay \$41,000 more per year. This hidden tax on a private pay resident results in depletion of assets and lost homes.
- Wisconsin nursing facilities, on average, lose between \$70.66 and \$78.58 per day for each Medicaid resident they serve. This growing loss number is creating added pressure on the viability of nursing facilities.
- The proportion of Medicaid residents in nursing facilities is rising. With fewer residents to cost shift the Medicaid loss burden to, many nursing facilities have downsized their bed capacities, while other facilities have been forced to close as the only option. This has resulted in fewer nursing facility beds being available in Wisconsin, and fewer options for local employment, particularly detrimental in rural areas.
- Already in 2019 9 facilities have closed bringing the total to 30 facilities that have closed since **2016.** The Medicaid losses that facilities sustain are a significant contributing factor to these facility closures.
- The 85+ year old population demographic is set to increase by 140% from 2010 to 2040. These individuals most often access the critical care offered in nursing facilities. This demographic change will require more available nursing facility beds, not further reductions in access.
- Direct care costs, the costs to provide hands-on care to residents, were underfunded by \$99,800,000 in the 2017-18 payment year. Increases to this cost center increase the likelihood for increased wages to employees who provide the direct hands-on skilled care. LeadingAge Wisconsin 2019 Medicaid Loss Study

Each year LeadingAge Wisconsin examines Medicaid reimbursement for skilled nursing facilities (SNF's) in Wisconsin. For this study, 2017 Wisconsin Medicaid Cost Report data was examined and compared to rates received in the 2017-18 payment year (July 1, 2017-June 30, 2018). Key findings from this study are included in this report, as well as per facility losses presented by Wisconsin legislative district.

Key findings include:

- 100% of SNF's in Wisconsin experienced a Medicaid loss.
- The total deficit that SNF's were burened with in 2017-18 was \$324,800,000.
- The Direct Care Deficit (difference between wages and benefits paid to front-line caregiver staff and reimbursement received in the Direct Care Cost Center) was \$99,800,000 in 2017-18.
- The average facility lost \$78.58 per Medicaid resident, per day.
- Medicaid reimburses SNF's at a rate of 68 cents per dollar. Meaning that for every dollar of expense a facility incurs to treat a Medicaid resident, they are only reimbursed 68 cents.

* Outliers were determined by comparing total expenses per patient day and per patient day private pay charges as reported by the facility. If a facility's per patient day costs exceeded the per patient day private pay charge by \$100 or more, the facility was considered an outlier. This methodology of identifying outliers resulted in a lower per patient day and total loss number than had the outliers been included in full. **This figure reflects actual non-outlier losses; outlier losses were assumed at the non-outlier average of (78.58) ppd.

***Medicaid reimburses at 68 cents for every dollar of expense.
