- Coordinating preparation of the annual budget
- Preparing for and participating in annual audits for financial statements and 403(b)
- Monitoring budget performance and making recommendations of corrective action; monitoring capital budget
- Maintaining and recording transactions related to self-funded benefit plans; participating in insurance renewal decisions
- Directing preparation of annual Nursing Home Medicaid Cost Reports
- Working with the Financial Committee of the Board, monitoring and managing cash flow, investments and financial risks
- Selecting, coaching and evaluating department staff
- File federal and state forms, including W-2s, quarterly 941s, Unemployment Reports, & 5500s; oversee filing of the 990s.

Requirements for this position include:

• Bachelor's degree in accounting or equivalent experience

- Minimum of five years' experience in a health care setting, including at least two years of financial leadership experience
- Demonstrated knowledge of financial principles, included financial analysis, budgeting, reimbursement planning, internal control and reporting
- Knowledge of applicable financial regulations and compliance requirements in a healthcare setting
- Ability to understand and address complex issues affecting healthcare, such as regulatory changes
- High ethical standards and the ability to work effectively with others
- Demonstrated proficiency in financial software and systems
