




Percentage of Recertification Surveys with Findings of Harm or Jeopardy






Average Number Federal Health Citations per Complaint Survey



Percentage of Complaint Surveys with Finding of Harm or Jeopardy



Percentage of Complaint Surveys with Substandard Quality of Care





Immediate Jeopardy Citations 2000 - First Half 2016 (thru 6/30/16)








Percentage of Complaint Surveys Citing Harm or Jeopardy
