 - § 488.438 Civil Money Penalties: Amount of Penalty
 - §488.404 Factors to be Considered in Selecting Remedies
 - SOM 7516

Hypothetical #1 – Nursing Home 1

- Recertification Survey completed 09/08/2016
 - F441, S/S: K
 - IJ situation 09/06/2016-09/07/2016
 - Continued at S/S: E
 - No F SQC or higher citations in the past 3 years
- Substantial Compliance 09/20/2016
- No other citations in the survey cycle

Hypothetical #2 – Nursing Home 2

- Complaint Survey completed 09/21/2016
 F₃₁₄ (S/S: J), F₃₂₃ (S/S: G)
 - IJ situation 08/20/2016 09/20/2016
 - F314 continued at S/S: D
 - Staff showed a disregard for resident care
 - DON knew of the problem but failed to act

Hypothetical #2 – Nursing Home 2

- Significant history of F SQC and higher citations in the past 3 years
- In the previous survey cycle
 F₃₁₄ (S/S: G) and a per-day CMP imposed
- Substantial Compliance 10/21/2016
